FOLLOWING NATIONALITIES REQUIRE PRE-ISSUED VISA TO EGYPT THROUGH EMBASSY / CONSULATE: Canada, Israel, India, China, Pakistan, Turkey, Nigeria, Morocco, Tunisia, Algeria, Lebanon, Syria, Lybia, Sudan, Burundi, Sierra Leone, Rwanda, Philipines, Moldova, Iran, Liberia, Sri Lanka, Ghana, Mali, Thailand, Bangladesh, Afghanstan, Niger, Indonesia, Palestine, Iraq, Eriteria, Chad, Somalia, Ethiopia. Multiple entry Visa is required in order to be able to disembark after one week of cruise Red marked countries can apply for e-visa 2. OTHER NATIONALITIES WILL BE ABLE TO: - Apply for a multiple entry e-Visa before departure (60\$ / person) valid also for the return to Egypt. In case guests are not able to produce the multiple entry Visa online before the departure, they can purchase the first Entry Visa sticker directly at the airport in Hurghada at government offices, paying the equivalent of USD 25,00. The second Entry Visa sticker required at the end of the cruise when the ship returns to Egypt, must be purchased directly on board at a cost of EUR 29,00. This alternative solution is not valid for those nationalities requiring Pre-issued Visa Through Embassy/Consulate click here -> E-Visa NOTE: Egyptians nationals and passport holders, indifferently if residing in Egypt or in any other country, are not allowed to embark and disembark fromSokhna. Safaga is the only alternative Egyptian port where allowed embark/disembark. Same for the transit and must remain onboard ship when callingSokhna. All Egyptian passport holders (both residing in Egypt and outside) will be authorized to embark ship only if in possession of an already issued Saudi Arabia Visa and no longer with the application receipt even in presence of their request to remain onboard without going ashore during the day of call in Saudi Arabia	NO SPECIFIC VISA REQUIREMENTS FOR TRANSIT JORDAN. All transit guests will receive an entry stamp for the day of call.	An "e-Visa Transit by sea 96hrs" is requested to enter the country by paying an Administration/Insurance fee starting from USD25,00 (depending on the insurance chosen),whose link is: visa.mofa.gov.sa It is strongly suggested to apply the "e-Visa Transit by sea 96hrs" before ship embarkationas well as using preferebly "VISA bank credit card" or "MASTERCARD bank credit card"and print hardcopy of it. All guests can alternatively apply for Tourist Visa upon arrival at the cruise terminal Immigration desk, whose cost is 128 USD If guests do not wish to go ashore, they can remain onboard during the port of call and no Visa payment is needed The following nationalities are not allowed to apply for transit e-Visa to Saudi and must refer to Embassy / Consulate: Israel, Turkey, Iran, Lebanon, Libya, Yemen, Palestine, Syria, Afghanistan.

WINTER 2023/24 EGYPT, JORDAN, SAUDI ARABIA	EMBARKING SAUDI ARABIA 1) PASSPORT HOLDERS of countries below listed are eligible to receive a Tourist e-VISA to be required before arrival (https://visa.visitsaudi.com/): Andorra, Austria, Australia, Belgium, Bulgaria, Brunei, Canada, China (Including Hong Kong And Macau), Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Holland, Hungary, Iceland, Ireland, Italy, Japan, Kazakhstan, Latvia, Liechtenstein, Lithuania, Luxembourg, Malaysia, Malta, Monaco, Montenegro, New Zealand, Norway, Poland, Portugal, Romania, Russia, San Marino, Singapore, Slovakia, Slovenia, South Korea, Spain, Sweden, Switzerland, Ukraine, United Kingdom, United States (USA). The e-VISA must be printed in 3 hard copies. Price is about USD 128. (alternatively possible to apply for Visa upon arrival at the same price) 2) All other nationalities can receive Tourist Visa via any Saudi Embassy / Consulate.
